The third Saturday match got off on the right foot with a great breakfast of biscuits and gravy, scrambled eggs, sausage, coffee, and orange juice, prepared on the spot and served up by Just George and Kentucky Gal. For the shooting part, Cowboy Earl had suggested we use his shotgun knockdown/clay pigeon tosser and his stationary clay pigeon holder, which we did. I had already planned a stage that included a provided Handi-Rifle and one cartridge for an optional bonus shot, not to mention a "long range" Nevada Sweep. So, by the time the dust had settled, we had probably managed to make just about everybody happy—there was bound to be something that you liked out there.


## The IAC 93/97 is Approved for SASS Wild Bunch

After several years, SASS has decided that this shotgun, a Chinese made clone of the Winchester Model 97 which includes the unfortunate addition of a Model 93-style cut-out on the ejection port, can be used in SASS sanctioned Wild Bunch matches. The gun remains on the banned list for Cowboy Action Shooting on the grounds that the enlarged port gives a competitive advantage when single loading, which is the way most shooters use a 97. This decision is explained by the fact that in Wild Bunch, the shells are loaded in the tubular magazine at the loading table, so the competitive advantage doesn't come into play.

These are good shotguns, built like a tank and very reliable. There are currently none being imported, and unless SASS comes to its senses and allows it for CAS, there probably won't be any more. I don't know anybody who believes in the "competitive advantage" associated with the port cut-out, but then, I don't know anybody in the SASS hierarchy.

Meanwhile, if you have one, you can use it in RRV monthly matches, and you can also use it in our "Professionals" side match at *Defend the Roost* in May. However, since *DTR* is a SASS-sanctioned event, you will not be allowed to use it in the 10 stage main match or other side matches.



Our membership application is here [RRV Membership Application](#) Annual membership dues for the RRV are: single membership \$25, member and spouse \$30, family membership (including children under 18 living at home) \$35. First time shooters will be able to take their FIRST (1) NEW SHOOTERS CLASS for \$10, any subsequent new shooters class or RRV match shoot will be \$10 members, \$15 non members. Donations for shooting regular monthly RRV matches will be \$10 members, \$15 non-members. Memberships run from September 1 - August 31. New memberships purchased after September will be prorated depending on the number of months remaining and the type of membership.
